
### SHORT TERM ACTION POINTS




## 2. Upgrading Infrastructure offices and Nurturing Innovation and Startups:

This PreIncubation/Incubation facility will be accessible to students, staff and faculty of all disciplines across the institution.


## 3. Making Innovation Pathways for Entrepreneurs at Institution Level:
